## Scope of Work

Quote submissions by the proposer guarantees each outboard boat motor bid on will include installation and the completed boat, along with the freight packaged old motors will be delivered to the Collier County Sheriff's Office (CCSO) no later than **Monday, August 2nd, 2021** The cost of removal and installation must include proper crates to transport the old motors, all labor charges and any other rigging or propietary pieces such new tie bar, new throttle binnacle, new smart craft engine monitoring display that may be necessary for the motors to operate properly. To better help acount for this, the current vessel layouts are listed below:

<u>Vessel #505</u> is a 2012 25Ft Parker Marine Center Console with Twin Suzuki 300HP four stroke outboard motors. This vessel will need a full package that includes Motors, Smartcraft Vessel View, Throttle Binnacle, Steering Pump, Wiring Harnesses and Motor Tie Bar.

<u>Vessel #504</u> is a 2018 33Ft Conch Center Console with Twin Mercury Verado 350HP four stroke outboard motors. This vessel currently has Mercury Components so the bid should include only components that are necessary to upgrade to the 400HP Mercury motors.





Once the full installation is complete, the distributor shall make arrangements for the completed boat and old motors to be delivered to the Procurement Bureau and will coordinate the delivery date and time with a member of Procurement so someone is present to accept the delivery. Qualified motor vendors submitting a quote shall confirm delivery no later than **Monday, August 2nd, 2021** in their submission.
